

Terms and Conditions of own place entry in the Great North Run, 14th September 2025 (the “Event”)**Participation**

1. You enter the Event entirely at your own risk and Anthony Nolan shall not be liable for any injury or loss which you may suffer or incur as a result of your participation in this event, unless such injury or loss is incurred as a result of Anthony Nolan’s negligence.

2. I will inform Anthony Nolan Events Team immediately if I am unable to take part in the Event.

Fundraising target

3. I pledge to raise as much as I can for Anthony Nolan through my participation in the Event.

Donations and payment terms

4. I will keep details of the names and addresses of, and amounts donated or pledged by, all donors and provide such details to Anthony Nolan on request.

5. I will regularly pay all money collected on behalf of Anthony Nolan to Anthony Nolan directly to the Anthony Nolan team by;

- Paying online with your credit or debit card
- Using a fundraising website such as www.justgiving.com or www.enthuse.com
- Calling the events team on 0303 303 3000 with your credit or debit card details

6. I will send an accompanying breakdown of how the money was raised and return all used and un-used sponsor forms.

Fundraising

7. I will comply with any fundraising guidance or advice issued by Anthony Nolan.

8. I will collect money only on behalf of Anthony Nolan in connection with the Event.

9. I will use only lawful means to fundraise for Anthony Nolan and will not do anything that harms or is likely to harm the Anthony Nolan reputation.

Personal data and images

Health, safety and fitness
