#### **Participation**

- 1. You enter the Berlin Marathon entirely at your own risk and Anthony Nolan shall not be liable for any injury or loss which you may suffer or incur as a result of your participation in this event, unless such injury or loss is incurred as a result of Anthony Nolan's negligence.
- 2. I will inform Anthony Nolan Events Team immediately if I am unable to take part in the Event.

# **Fundraising**
