

## **Terms and Conditions of Ballot entry in the 2025 Berlin Marathon, 28 September 2025 (the “Event”)**

### **Participation**

1. You enter the Berlin Marathon entirely at your own risk and Anthony Nolan shall not be liable for any injury or loss which you may suffer or incur as a result of your participation in this event, unless such injury or loss is incurred as a result of Anthony Nolan’s negligence.
2. I will inform Anthony Nolan Events Team immediately if I am unable to take part in the Event.

### **Fundraising target**

### **Donations and payment terms**

## Fundraising
